# Scholarship Fund

We are pleased to announce that on a proposal made by the President, the Executive Committee unanimously agreed to launch a Scholarship Fund to provide financial assistance to a needy student in the South affected by the Tsunami disaster. Mr. Berty Fernando himself has visited Rahula College, Matara and after discussing the proposal with the Principal and teachers of the College had identified a deserving student who is studying for his O/Level Examination. He had performed very well in the All Island fifth Standard Scholarship Examination by obtaining a total of 175 marks. Presently, he is a Prefect of the School and takes part in Athletics. His father is a fisherman and mother is unemployed. He one sister younger to him and the family was living in a house near the Polhena beach before it was completely damaged. They are now living with one of their relatives. The father is going through a very hard time with no regular income even to meet the basic day to day needs.

The Committee having discussed the proposal at length decided as responsible citizens of the country to contribute even in a small way to bring some relief to at least one member of this Tsunami affected family.

The Scholarship Fund was officially launched on 20<sup>th</sup> April 2005 with 11 Committee Members present at the meeting agreeing to contribute Rs.1,000/- each as a starter. With this money, we commenced sending Rs.2,500/- per month to this boy beginning from May 2005.

We now solicit the co-operation of each and every members and appeal to them to contribute towards this fund to enable us to help this student to continue his studies and participate in Sports and other extra curricular activities uninterrupted. We will keep all members informed of this boy's progress in his studies and other relevant details of the family through future issues of this Newsletter. # A PEEP INTO THE PAST – Story No.03 'KADIYA'

Some of you may still remember that dynamic personality ROBIN EBERT who served the Company in the late sixtees and thereafter as an Area Manager. Mr. Ebert who joined Singer after serving the then Royal Navy was a strict disciplinarian. Probably the training he received whilst serving the Navy moulded him not only to be a well disciplined man but also ensure that discipline was maintained by all and

sundry in whatever sphere of activity he engaged himself, whether workwise or otherwise.

During the bygone days, the mention of his name would bring instant fear to all those who worked under him inclusive of District Managers. He was a workaholic and expected all those who worked under him to follow suit. For this reason he was appropriately nicknamed 'Kadiya' by his subordinates.

During this era, the Company field operations were divided into just four areas North, South, East and West. Mr. Ebert was in charge of the South, which comprised three Districts Moratuwa, Galle and Matara. When Mr. Ebert took over the South from the Senior Area Manager, the late Mr. M.L.M. Rasheed in 1978, I was in charge of the Galle District where the Shop Managers were all seniors in this category with a number of years experience. One such Shop Manager was Mr. J.W. Kudahetty who is today a member of our Association.

One day in February 1978, I was at the Galle Shop carrying out a physical verification of the inventory held. By 8.45 a.m. Mr. Ebert entered the shop unnoticed by anyone. After exchanging greetings, Mr. Ebert inquired for Mr. Kudahetty. The time now was around 9.15 but Mr. Kudahetty had not arrived at the shop. Visibly angry, Mr. Ebert first gave me a pep-talk on the importance of maintaining discipline in the district. He added, 'If there is no discipline, nothing will succeed. Look at this man, the time now is 9.30 and he is still not here. He should be an example to his staff by coming to the shop before anyone else. Let him come, I know the reason why he is getting late'. So saying Mr. Ebert occupied the Manager's seat. A few minutes later, Mr., Kudahetty arrived at the shop. Seeing him approaching the Manager's table, Mr. Ebert quickly got up and said 'Good Morning Sir'. Seated on the opposite side of the table, I was baffled when I heard an Area Manager addressing a Shop Manager 'Sir'. Mr. Kudahetty apologized for coming late and tried to say something but Mr. Ebert without giving him a chance to open his mouth said 'No Sir, no need to apologise, you are my boss and I am your Shop Assistant.' Mr. Kudahetty now realized what had happened but pretended to be ignorant and asked Mr. Ebert 'Sir, why di you say I am your boss. You are my Area Manager'. Replied Mr. Ebert, 'No, no Mr. Kudahetty within these four walls, I am your Area Manager but to the outside world, I am your Shop Assistant.' Mr. Kudahetty was dumbfounded and shocked at what he had uttered as a joke at the Club the previous evening had reached Mr. Ebert's ears within a couple of hours. Leaving no time for Mr. Ebert to launch another verbal attack,. Mr. Kudahetty laughed loudly and told Mr. WELAWATA "KANA BONA KIYANA DE GANAN GANNA EPA, SIR' (Sir don't take seriously what is said whilst eating and drinking).

Mr. Ebert's attitude changed immediately and he started to smile but that smile was short-lived. Mr. Ebert re-commenced his verbal attack on Mr. Kudahetty and told him in no uncertain terms 'Mr. Kudahetty, what you say and do outside this shop is your business but when it comes to work, you must be disciplined and set a better example to your staff. Don't ever repeat what you have done today. Come to the shop a few minutes earlier than the others and attend to your duties as a responsible Manager. Take this as an advice and also as a warning. Now, come let us go out and have a cup of tea.' So ended the early morning encounter between Kadiya and Kuda.

(Note: With due respect to the late Mr. Ebert who died in Australia about three years ago, I have related this story for the reading pleasure of our members. I have tried my very best to recall the incident as accurately as possible. The year, the month, the location and the incident is 100% correct. Only the dialogue between Mr. Ebert and Mr. Kudahetty may not exactly be the same as spoken by them on that day.)
