The Singer cricketers followed the advice of their Chairman to the very letter, and playing as a single unit, pulled off a sensational win by 41 runs to emerge Champions. Singer also beat another strong side Mercantile Credit, team packed with stars led by Arjuna Ranatunga. Singer also beat yet another strong side Hongkong & Shanghai Bank in the preliminary round on their way to the Final.

After the conclusion of the match, Mr. Amarasuriya who was with us right throughout the game suddenly vanished from the scene. All of us were wondering what happened to him and started looking for him all over the pavilion and grounds. A few minutes later, Mr. Amarasuriya walked into the players' dressing room to the delight of everyone, carrying with him a bottle of Champagne, which he proudly shared with the team and the support staff.

I feel this article is incomplete if I do not pen a few words about the vital contribution made by Nelson Mendis (Manager cum Coach). His high level of motivation, advice and guidance no doubt helped the Champions in their task.

Dhammika Ranatunga (Captain) and Chandana Amerasinghe (Vice Captain) and their team of young players put their heart and soul into the game and pulled off a memorable victory. This historic victory is a personal achievement for the Patron of Singer Sports Club Mr. Hemaka Amarasuriya, Kumar Samarasinghe (Cricket Secretary) and the writer who was then the President of the Sports Club.

Cricket At Singers

When I joined Singer Sewing Machine Company as a Trainee District Manager in 1975, the company did not participate in the Annual Mercantile Cricket Tournament. A few of us, M/s Hemaka Amarasuriya, Gamini Wasalathanthri, the late Neville Daniels and the writer decided to enter a team in the G Division in 1977. Our first match was against Aitken Spence Plc This was a disaster. Aitken Spence Plc batted first and scored 200 odd runs in their innings. At one stage they were in a difficult situation, losing 3 wickets for 30 runs, and Daya Livera without the permission of the captain commenced bowling his first over to Angelo Wickremaratne (former Peterite captain), who scored 24 runs in this over, and went on to score 94 runs. At the end of Daya Livera's over. Mr. Amarasuriya questioned me as to why I gave Daya Livera to bowl. I told him that he commenced bowling without my permission, He immediately informed me to drop him for the next match.

We recruited Mohan De Silva, Mohan Moothathamby, Russel De la Motte and Premalal De Silva. In 1980 we were in the D division. I could vividly remember the final of this Division where in we played against Mackwoods at NCC grounds. Mackwoods was captained by Ranjit Fernando, a Sri Lankan cricketer and had a team of good cricketers including Kunchu Balendren, a leg spinner, who had played for St Benedict College Kotehena. Mackwoods batted first and scored 170 runs Our top order failing badly. When I went in to bat we were 40 runs for 4 with our top order back in the pavillion and Mr Amarasuriya was at the other end. He came up to me and said" Ranjit we have to win this match so put your head down and bat ". We slowly pushed to score to 173 for 4 having put on a partnership of 133 runs. When I left Singer (Sri Lanka) Ltd in 1982, we were in the B Division.

Mr. T.B-----Colombo Apothecary's

Mr T.B. was an Executive at Colombo Apothecaries and he had purchased a machine from Chatham Street Shop on hire purchase. terms. Mr. T.B. was a sweet talker but an absolute liar,. After the initial payment he had stopped paying any installments. Mr. Maniam had paid several visits and was not successful. When I met Mr. T.B. he told me politely " Mr. David you seem to be a nice person and Mr. Maniam is a wonderful man. Do not worry I will pay you next week." Since the account was well over 6 months delinquent I decided to revert the complete machine. Next day we went to his residence at Enderamulla. His wife was there. I informed her that Mr.T.B wanted us to take the machine as he cannot make regular monthly payments. We took the machine into our possession. The following day Mr. TB walked into the showroom took the machine after paying the full amount.
