ANNUAL GENERAL MEETING



SCHOLARSHIP FUND - ' HELPING THE NEEDY STUDENTS'

Our Association started this project in July 2015 with the sole objective of helping school going children from poor families. Initially, 12 students from the Stanley Thilakaratne Primary School, Mirihana were selected. Each student was given Rs.500/= per month and the money was utilized to purchase books, stationery, shoes etc. under the guidance and supervision of the Principal and teachers in charge. Furthermore, in 2015 and 2016, we donated gift parcels containing English story books to 170 students for their English Day celebrations. Our support and participation at these events was highly appreciated by the Divisional Director of Education, other invitees and by the Principal and parents of the school.


In addition to the above, at the request of the Principal, we donated Rs. 10,000/= for the Prirth Ceremony held at the school in March 2017. From June 2017, the number of students who received financial aid was increased to 15 incurring an expenditure of Rs. 7500/= a month and this is being continued to-date. With a view to promote sports activities in the school, we donate Rs. 2500/= a month to the Principal to conduct swimming classes for children of the school at the DharmapalaVidyalaya, Pannipitiya. even though we are now finding it difficult to continue with these programs due to lack of funds.

As you are aware, on an appeal made for contributions earlier we received generous donations from a few members to the Scholarship Fund which helped us to carry on with these programs even in a small way. We now need money in the kitty with a view to continue with our social responsibility programs and hence this appeal to all our members to help with donations which will be duly acknowledge by our Treasurer.

Singer is a name now famous among the students and parents in the area and we can be proud of being a member of the SINGER FAMILY.

Anton Silva, former HR Manager of Singer Industries (Ceylon) PLC passed away on 16th November 2018, after a brief illness.

Anton was born on 2nd January 1951, only child of the late Mr. & Mrs. Vincent Silva of Moratuwa. He started his schooling at St. Sebastian's College, Moratuwa in 1956. He excelled in cricket and other extracurricular activities at St. Sebastian.

After leaving school, Anton joined Bata Shoe Company in 1973, and worked under the Personnel Managers, Mr. RanjithAbeyratne, Mr. J Ellawala and Mr. C L Cooray. His loyalty and commitment to work made way for his elevation to the post of Personnel Manager at Bata at senior level in 1994.

Anton participated at many HR related conferences and seminars in many countries during his period at Bata. His knowledge, experience and contribution in HR activities were recognized by the International Labour Organization (ILO) by selecting him as the "Best HR Manager in Sri Lanka" in September 1994. This prestigious award also made way for him to attend the Annual ILO Conferences overseas.

after completing a very successful career at Bata Shoe Company of 26 years, Anton joined the Management of Singer Industries (Ceylon) PLC as HR Manager, a Senior Management position in 2001. At Singer Industries, he achieved all the tasks assigned to him with dedication and some of the hard decisions he had to take were appreciated by his superiors as well as the subordinates. The HR Managers are normally not popular among the minor staff, but in the case of Anton, he was accepted and loved by his staff. The reason behind this is that he was a very humble and friendly person who mixed with everyone and made friends while being firm and fair in his decisions.

Anton retired from Singer in 2013 and started his consultancy career. He was a well sought after consultant by many Mercantile Sector firms, to sort out their HR problems. He helped many clients until his sudden demise in November. Anton was also an All Island Justice of Peace.

Our friend and colleague, after retirement from Singer, joined the Association of Past Employees of Singer. Anton was appointed as the General Secretary of the Association in 2016. During his period as the General Secretary, until his death, he was the live-wire in organizing many social activities and get-togethers. He

was a very jovial and fun-loving personality and got involved in singing and dancing at these gatherings, being a keen musician and a singer of repute. The sudden death of our friend is a great loss to the Association.

Anton leaves behind his beloved wife Sriyani, two loving and proud daughters, Ashini and Maneesha and his two lovely grandchildren.

His friends and relatives will miss this friendly personality's company.
