

SACKED FOR WEARING JEANS AND SLIPPERS

Ananda Perera's article titled 'Historic at the Labour Tribunal' (Newsletter Feb. 2016) prompted me to share a little bit of my first-hand experience in this forum which has 'Just and Equitable' as its theme. However I remember my boss Gamini de Silva telling me, "LTs are funny places", when I asked him how things went that day at the Labour Tribunal he just arrived from. "Krishantha Silva, one of my clerks in a company at Dehiwala, submitted his resignation stating that he had found another job at a higher salary than what he was drawing, and despite my assuring him of an even higher amount in January, three months hence, he regretfully left. Four months later he visited me seeking employment and explained that he had been dismissed for attending office on a Saturday, in denims and rubber slippers – a common practice among the office staff. I had no vacancy to offer him and felt obliged faute de mieux to seek relief for him in the labour tribunal. He was initially reluctant and cited financial strains in the litigation process and also enlightened me that his father was bed-ridden and his mother, a meager-wage rubber tapper. I assured him that I will personally handle the matter gratis, and filed application for compensation for wrongful termination as I guesstimated reinstatement could lead to subsequent victimization.

The case was called in Labour Trubunal No. 8 before LT President Francis Weerapperuma, but neither was the respondent company present nor answer filed. I moved court that the case be taken up ex-parte on the next date if the respondent defies court. On the second day, lawyer for the respondent company took up the position that the applicant's services were terminated for poor attendance and since he was a probationer, the tribunal cannot sit in judgment over the decision of the employer – the sole authority to judge the applicant's suitability for permanent employment. Apprising court that respondent's submissions were casuistry, I took up the position that the labour tribunal can examine the grounds for termination for the purpose of ascertaining whether the employer had acted mala fide or with ulterior motives, or was actuated by motives of victimization. I specified that courts have laid down the principle that relief would be granted to a probationer in respect of termination of services if the employer had acted mala fide and reiterated that the case be fixed for trial.

Confronted by the LT President on the development, the respondent began to back-pedal and agreed to reinstate the applicant which I objected to, drawing attention to the fact that I had not claimed same in my application. To cut short, Krishantha received three months salary as compensation, underlying the theme of the tribunal.

In a similar instance, I filed application in the Panadura Labour Tribunal on behalf of a salesman of Galkanda Groceries, Panadura who complained to me that he was dismissed unfairly. When this case was taken up before LT President P. Thamotheram, I submitted preliminary facts in English as is the normal practice at Vauxhall Street. The LT President interrupted me to say, "You know English, I know English but the stenographer doesn't" and I switched over to Sinhala. In different circumstances, I was present in the Negombo Labour Triubunal when a case came up before LT President Mr. Ranhoti in which gratuity payment was awarded to a domestic servant despite provision not being available for same under the Gratuity Act.

Applicant claimed three months unpaid salary from the respondent mistress who admitted employment. She attributed delay in payment to unexpected financial losses from business and mentioned that the applicant had vacated the residence and there was no form of contact whatsoever. Applicant's lawyer next moved for gratuity payment and told court that the domestic had six years continuous service with the respondent. The respondent, not represented by counsel apparently unaware of gratuity clauses, agreed to payment and the LT President said that since respondent agrees, payment is awarded. What is happening here, I wondered. Would the maid next shout out like Shylock in Shakespeare's Merchant of Venice:

"A Daniel come to judgment! Yea a Daniel. O wise young judge, how I do honour thee!" when the learned doctor (Portia) sitting in judgment proclaimed: " A pound of flesh is thine. The law allows it and the court awards it".

I later drew conclusion in this land mark case that the gratuity payment was in personal gratuity for service to the household.

TUK TUK MAHATTHAYA

This is an incident which happened in the late sixties, may be 1968 or 1969. I was the District Manager in charge of Kurunegala District which comprised of 6 shops, namely Kurunegala, Kuliyapitiya, Mawathagama Narammala, Chilaw and Nattandiya.

One day I was engaged in carrying out an inventory check of stocks held at Kuliyapitiya Shop. Quite unexpectedly, Mr. Robin Ebert, my Area Manager who was an ex Naval Officer, a strict disciplinarian, very active, very methodical in whatever he does walked into the shop. Being the methodical man, he made sure he had everything he needed for the tour. His tour paraphernalia included the Typewriter, Mosquito net, Alarm clock, Torch, Pens and Pencils and official stationery apart from his personal belongings to last a fortnights tour.

After exchanging greetings and partaking a nice cup of tea provided by the shop manager, I continued with the inventory check. Mr. Ebert, as usual commenced his pet subject of visiting bad hire purchase accounts. Selecting a few F128s (Hire Purchase Accounts Payment Record) he stepped out of the shop saying "I will see you at the Rest House in the evening"

At about 5 p.m. in the evening, he returned to the shop with the shop assistant carrying two machine heads which Mr. Ebert had re-possessed from two delinquent accounts. When it was time for the shop to be closed for the day, he suggested that we stop work and go the Rest House for a peaceful evening and good nights rest.

Mr. Ebert had been reserved a room on the right hand side of the corridor facing the entrance. It was one before the last. The last room was occupied by the Kuliyapitiya Magistrate. My room was at the other end of the corridor.

After dinner, we went to our respective rooms to enjoy a peaceful night. The next morning when I came out of my room, I was surprised to see Mr.Ebert coming out from another room a little away from the original room. Immediately, I walked up to Mr.Ebert and inquired what happened after I left him. Without any hesitation, he said "That idiot of a magistrate, who was suffering from insomnia made a complaint to the Rest House keeper that he could not sleep as the noise of my typewriter was disturbing him, Furthermore, he had delivered an exparte judgement instructing the Rest House keeper to move Mr. Ebert to another room immediately. Poor Mr. Ebert.

This incident spread like a wild fire in the District and Mr.Ebert who was until then called "Kadiya" was thereafter known as "Mr. Ebert the Kadiya alias Tuk Tuk Mahaththaya"
