Subsequent to this detection, the Government imposed a ten day knockdown islandwide to curb the spread of Corona cases. Since then, knockdowns were imposed on and off throughout the years 2020 and 2021 resulting in the activities of Sri Lankans, including social gatherings, meetings. sports events and performing religious obligations being canceled. Even those who lost their lives due to natural reasons such as old age, sickness and accidents had to say 'good bye' to their family members, friends and relations within 24 hours of issuing the death certificate. Let us pray and hope that 2022 will be an year with a silver lining in a dark cloud and pave the way for a pre 2020 era.

## THE CASE OF THE TIGER ATTACK ON COLOMBO BY T.V. PERERA

I crouched against the wooden panels of a closed shop as bullets whizzed past me with vicious cracks and thudded into the brick wall a mere five feet away. With no intention of getting shot and killed in this injudicious encounter, I did not dare move although perilously exposed to the world's most dreaded terrorists - the LTTE tigers. The firing stopped as suddenly as it began and on taking a cautious look, I saw the muzzle of a gun being drawn back from the window of the St. Philip Neri's church, in the heart of Pettah. This frightening experience was not perversely a holiday in hell, it was a spa for my sensations. The then Group Personnel Manager Gamini de Silva assigned me to collect certain documents from the chairman's secretary, and having left the Singer factory I was on my way to Chatham Street when at the Regal Theatre halt the police barred the bus from entering the Colombo Fort area. I nearly choked in fury on learning that the LTTE was attacking Colombo (Colombatakotigahanawa) but bravely walked ahead, only to meet stern policemen near the Lake House roundabout who were not there to mince words, and there certainly were no frills on their orders. I drowned my thoughts of picking up the cricket-ball-like round stone I noticed close to the pavement to fling at the LTTE tigers, and quickened steps along D.R. Wijewardena Mawatha to cut across the Fort railway station and thereby get to the Singer Sri Lanka office, only to find the ticket counters, platforms, and even the gates at the station, desertedA milling crowd had converged on the railway station verandah with all heads turned towards the bo-tree junction from where a pall of thick black smoke arose; evidently buildings on fire. My eyes rested on a policemen in a bath of sweat, uttering a string of curses and blasphemies as he paced the verandah. His damp shirt was stuck to his body, beads of perspiration rolled down his face and his eyes were wide with fright. A lovely target for the LTTE tigers, he seemed to have already seen death. I watched him for a minute before pushing my way through the crowd onto Olcott Mawatha. Although there were some curious people, some gazing at the burning buildings and some at the looters nearby, the road was completely deserted of motor vehicles

I was at this very spot some years back, at the time Governor General William Gopallawa in his immaculate white national suit and contrasting black gloves unveiled the statue of Colonel Henry Steele Olcott after whom Norris Road in the Pettah was renamed. The GG's security escort was a mere unarmed police inspector who rode in the front seat his car, but that is a time buried and forgotten with the years.

Across the road, shops whose owners form a miniscule part of the big bourgeoisie spawned by the market economy and the prevalent cosumerist lifestyle had put up shutters while looters of Victoria Hotel carried away bottles of liquor. Pettah thugs, armed with iron rods blocked and chased back a car which came past Chalmer's Granary. On spotting the dark, burly, bearded men inside, there were shouts of 'koti, koti' and stone missiles being hurled at the fleeing vehicle. A Frenchman, carrying a half-size carrom board came upto me and enquired as to how he could get to the airport. I directed him to the Central Bus Stand but doubted if he could find any form of transport in the midst of the upheaval.

Suddenly the sound of crackers rendered the air. It was the overwhelming and startling burst of gun fire. Instantly there was panic, chaos, and shouts of 'Kotivedithiyanawa, duvapalla, duvapalla', as people shrieking at the top of their voices ran hither and thither for their dear lives screaming hysterically. The security of the city was marked by the fact that there was not even a policeman to counterfire. I too ran for cover and crouched against the closed shop wall on which bullets were now making pockmarks, and came out well after the firing ceased.

Minutes which seemed like hours passed, before a war tank rushed in and halted near the Fireworks Palace at Front Street junction. As troopers jumped out, by-standers shouted that the LTTE tigers were inside the church. The soldiers took cover behind light posts, their rifles aimed at the church and awaited firing orders. A second armoured car sped towards the bo-tree junction. At this crucial moment, the loud speakers at the railway station blared that the last train would leave in 10 minutes time followed by the announcement that a curfew will be imposed in half an hour. I rushed to the train leaving the soldiers to deal with the tigers and closed my mind to flinging a stone at the LTTE terrorists.

In office the following morning, everybody talked excitedly about the tiger attack on Colombo. When I apologized to GPM Gamini de Silva for failing in my mission, he brushed it aside to say how happy he was to see me in one piece. His secretary Damayanthi Maligaspe described the more ghoulish spectacles graphically and the higgledy-piggledy chaotic situation that prevailed in Ratmalana, which was of entrancing interest to me. When news broke out that the LTTE was attacking Colombo, all hell was let loose and everybody fled in a state of abject terror. The two carriage-way Galle Road converted into a single and was a chock-a-block with vehicles travelling non-stop, bumper to bumper in the Moratuwa direction. And all the while, I had been in the midst of a vicious grip of Velupillai Pirabhakaran's LTTE tigers.

As most of you are aware, another Singer Legend Mr. A.M.M.Nissar passed away on 5th August 2021 after a brief illness. Late Mr.Nissar was a founder member of the Association of Past Employees of Singerand held the important position of Treasurer from the very inception ie: from 24th June 2000 uptoJsnuary2019.

He was entrusted with the task of managing the finances of the Association due to his vast experience at Singer Head Office, first as an Accounts Clerk and thereafter as the Budget Manager. I am aware he worked late into the night, preparing the Annual Budget to enable the Management to submit the Budget proposals to the International Group Headquarters prior to the deadline. It is with such commitment and dedication that Mr. Nissar performed his duties as the Treasurer of the Association. His motive always was to add Rupees and Cents to the Association Kitty and this was clearly seen at every Annual General Meeting held when at the time Raffle Tickets were sold, he was at the forefront, walkin gthe length and breadth of the hall selling raffle to members.

He was also an active member of the Association participating in all the activies held indoors or outside.andrendered valuable service to the Sports Club as its Treasurer.

Mr. Nissar is no longer with us but the indelible impression he created as a loyal employee of Singer, a perfect gentleman and a true friend will

The outstanding jingle composed by Sunil with simple, powerful and meaningful lyrics touched the hearts of Sri Lankan consumers across all social strata and was sung in his on inimitable style. 'Anang-Manang Mama Kiyanne Ney, SingertaSamanaKisiwak Ney, Ganna Singer, MasuranWati, Gaththoth

Quite unassuming despite his unparalleled achievements, Sunil Perera, the musical genius, captivated music lovers across generations with his inimitable, powerful voice for over five decades

May he rest in peace and may his family have the strength to get through this difficult time.


